Herein, called the “Exhibitor”

AND

The Earl Hardy Big Rig Nationals Truck Show, herein called “Show”

1. The Exhibitor agrees to rent space(s) at the specified fee.
2. The space selected for the Exhibitor, will only be confirmed once full payment is received.
3. The Exhibitor, acknowledges the Show is an outdoor event and there is NO hydro or water in the trade show area. Generators are allowed, with turn off by 11:00 pm
4. The Trade Show area is serviced by Wireless inter-net.
5. The Exhibitor is responsible for supplying their tents, tables, chairs, etc.
6. The Exhibitor hereby releases and forever discharges the Show and its employees from and against all claims, of every nature and kind, for injury, losses or damages sustained by the entrant or to his/her person or property and hereby acknowledges that the entrant is solely responsible for his/her own multi-peril and public liability insurance to protect themselves, their employees and their equipment and the entrant hereby agrees to indemnify and reimburse the Show for any amount paid out and costs incurred by the Show as a result of any liability claimed for which the Exhibitor hereby acknowledges is his/her responsibility.
7. The Exhibitor is responsible for removing all goods and materials from their site after the event and leaving the space in a clean and orderly manner, as it was prior to the Show. They will be billed for the removal of goods or materials left behind and/or for the cleaning and/or repair of their site.
8. The Exhibitor is responsible for the security of their goods all perils at all times, during set-up and take down of their display as well as during the event.
9. The Exhibitor agree to staff their display at all times during the event hours.
10. The Show agrees to promote the event in trucking publications, media releases, posters in truck stops and on the Grand Bend Motorplex, web site.
11. Prior to the event, if the event is cancelled, for any reason, the Show will return the amount paid for the space rental. The Show shall not be liable for any expenses incurred by the Exhibitor for profit expected to be gained from the event.
12. Privacy Consent – The Exhibitor hereby consents to the collection, use and distribution of his/her personal information, set out above, by the Show. The Show respects your right to privacy. From time to time the Show may wish to disclose personal information you provided, in circumstances, when the Show believes it to be in your best interest (ie information to the Show & Shine contestants and/or promotions by a Show sponsor)
13. The Exhibitor may park personal vehicles, RV's, etc within the boundaries of their site.
14. The Show requests NO vehicle traffic during the event hours.
